The applications are required on Prescribed Form in **02 Sets** for above mentioned positions with attested copies of all certificates, degrees, testimonials, detailed marks certificates, experience certificates with specific dates, transcripts, equivalence certificates, CNIC, domicile along with passport size photograph on each set and a **Bank Draft of Rs.2500/-** drawn in favor of the **Treasurer**, **Muhammad Nawaz Shareef University of Agriculture**, **Multan**:
- 2. The candidates may apply separately for each post with separate application fee, who are intended to apply for more than one positions.
- 3. The foreign qualified candidates must attach equivalence certificates of foreign degree from Higher Education Commission of Pakistan.
- 4. Candidates already in service should apply through proper channel/NOC issued by the authority by due date, declaring that no inquiry whatsoever or investigation by any agency/department or trial by any court of law is pending against applicants. The Annual Confidential Reports (ACRs) grading for the last five years may also be recorded in the forwarding letter.
