### **Participants:**



### **Summary of Workshop:**

The basic purpose of the above workshop was capacity building regarding filing of Intellectual property (IP). The resource person introduced the IP and its different types (with examples)

including patents, copyrights, trademarks, geographic indications, industrial designs and plant breeders' rights. He also presented the history of IP protection from 2700 BC up to the recent time in addition to the legal framework of IP registration and role of intellectual property organization (IPO) in Pakistan. The importance of IPRs for development of Agriculture sector in Pakistan was also discussed. According to the IPO data, number of applications for IP registration was increasing every year, which was the confirmation of the IPs awareness in Pakistan. He further conducted a practice session for drafting IPR applications along with their application fees in committee room (Annex 2). At the end of the workshop, the certificates were distributed among the participants by the worthy vice chancellor. Photo gallery displays a few activities of the workshop.



2. Another group of students from IT department developed WEBSITE of the company

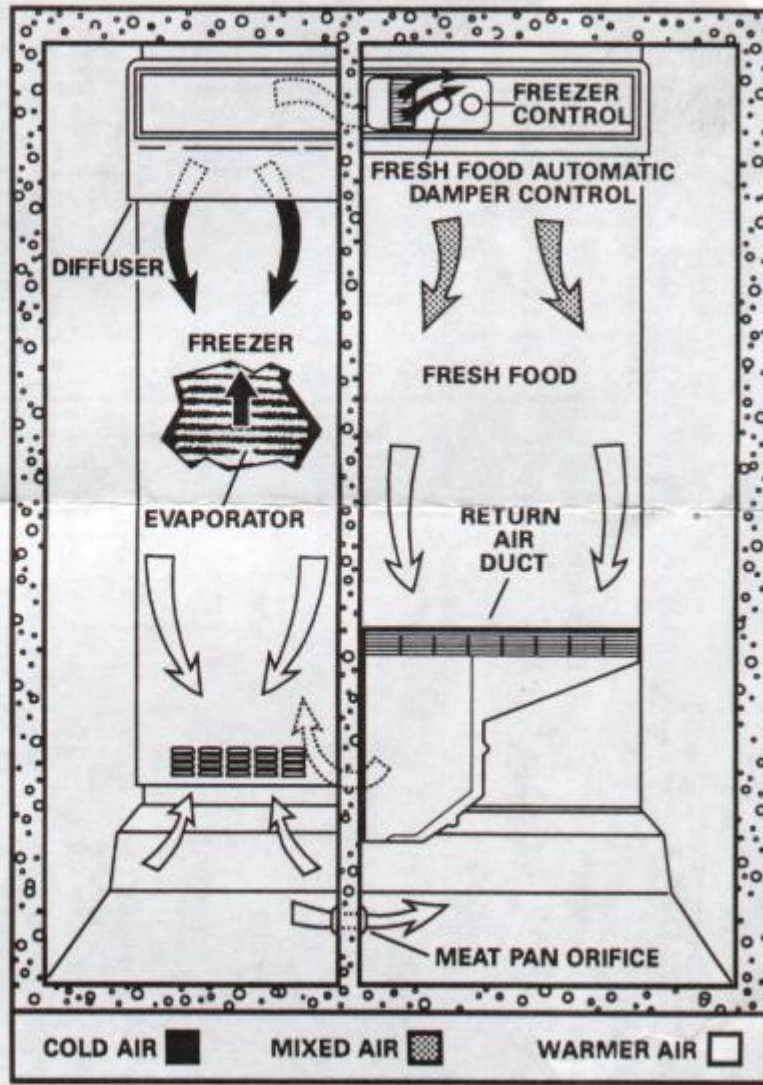
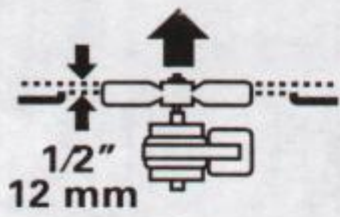
